staff should be atleast on par with those in
Government institutions of State;
- iii) This State Government reserves the right to withdraw
the above certificate at any time, if the management
fails to comply with the instructions of the State
Government such as illegal removal of teachers,
non-payment of salaries to the teaching and non-teaching
staff as per the approved scales etc;
- iv) Admissions should be made with bonafied date of
birth certificate.

- v) To collect the tuition fee and special fee etc., as prescribed by Government of Andhra Pradesh in G.O.No.379, Edn., dated 9.8.1985;
- vi) Strength in the classes should be increased as per rules;
- vii) The school management should follow the rules that are in force in Andhra Pradesh State;
- viii) The District Educational Officer, or his nominee should be invited when the management makes recruitment of candidates for various categories of posts;
- ix) Play facilities should be provided;
- x) The management should not collect donations either from the students or parents for admissions.
