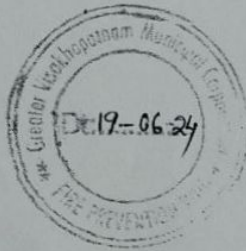

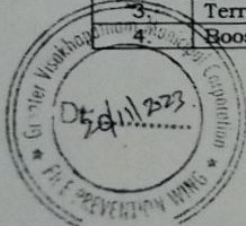

vii.	Mock drills should be conducted once in 3 months for initial two years. Thereafter, once in every 6 months.

The **Fire No Objection Certificate for Occupancy** issued to M/s.Kakathiya Academy of Education & Cultural Society, Kakathiya Public School, D.No.13-9-6/4, BC Road, Gajuwaka, Visakhapatnam is **valid for 03 years from 20-11-2023 to 19-11-2026** and the Management shall submit the application for Renewal of Fire No Objection Certificate two (2) months before the date of expiry.
